TEST HEADQUARTERS & TEST HOURS: Drawing for the TDU running order will be at 8:00 a.m. at Moberly Community College, Parking Lot by the Activity Center, 100 S Holman Rd, Moberly MO 65270. The first track will run at judges' discretion shortly thereafter. Drawing for the VST tracks will be held at 10:00 a.m. at Moberly Community College, Parking Lot by the Activity Center and will run at judges' discretion shortly thereafter. Per "Tracking Regulations" Chapter 2, Section 9. Exhibitors not present at the time of drawing may be marked absent.

ENTRIES: Entries will not be accepted without fees. Faxed, telephone, email and unsigned entries cannot be accepted. Entries not on an Official AKC form and photocopies of entry forms without the Agreement and Rules on the reverse side of the Official AKC entry form are not acceptable. No refund for duplicate entries or errors on entry blanks. Owners are responsible for errors in filling out entry forms & no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. Entry fees will be refunded within 7 days following the test for an alternate who does not compete. NO OTHER ENTRIES WILL BE REFUNDED.

Returned Checks do not constitute a valid entry fee. The Test Secretary will add the fee charged by the bank to the amount of each returned check.

DRAWING OF ENTRIES

The drawing shall be open to all interested persons. Entries for the TDU and VST test shall be accepted until the official closing date and time, even though the advertised limits have been reached. A random drawing of all entries will be held to determine which dogs will participate in the test. If the advertised limits are not exceeded there will be no drawing. When the advertised limit has been drawn, all remaining entries shall be drawn for a position on the alternate list.

Upon notification, alternates shall have the option of accepting or refusing the opportunity to participate in the test. In the event an accepted entry is absent on the day of the test, the first alternate entry present according to the order in which they were drawn, as set forth in the preceding paragraph, shall assume the vacant position.

CERTIFICATION: With each entry form for a licensed or member Tracking Test for a dog that has not passed an AKC Tracking Test, there must be filed an original written statement, dated within 12 months of the date of the Tracking Test, signed by a person who has been approved by the American Kennel Club to judge Tracking Tests, certifying that the dog is considered by him/her to be ready for such a test.

BITCHES IN SEASON: Tracking Regulation Chapter 2 Section 8. Bitches in season may participate. The Test Secretary and Judges are to be notified prior to the drawing for running order that a bitch(es) is in season. The last track(s) to be laid shall be reserved for the bitch(es) in season. If there is more than one bitch in season, a second draw for these bitches will be held.

ARBITRATION: The Show Me Agility Club of Central Missouri does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

AWARDS: Qualifiers for the TDU will receive a frame and certificate. Oualifiers for the VST will receive a ribbon.

The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed.
